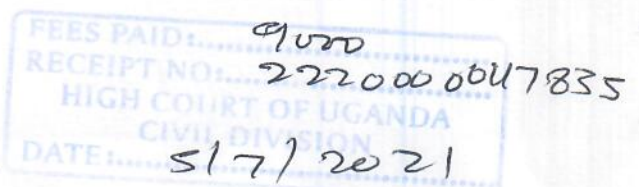


It is hereby ORDERED THAT;

2. An Order of Mandamus is hereby issued compelling the 2nd Respondent (The Medical and Dental Practitioners Council) to make Recommendations to the Minister of health on reasonable fees chargeable for the persons seeking and accessing COVID -19 treatment in hospitals.
3. The name of the Hon. Dr. Jane Ruth Aceng Ocerro (The 3rd Respondent) be replaced with The Minister of Health.

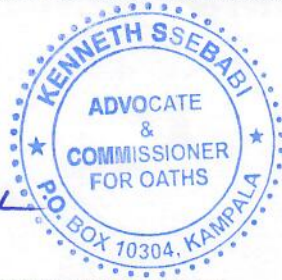
