

## MAKERERE WINS 5<sup>th</sup> ANNUAL NATIONAL INTER-UNIVERSITY CONSTITUTIONAL LAW MOOT COURT COMPETITIONS

On Friday 19<sup>th</sup> October 2018, The Center for Health, Human Rights and Development [CEHURD] through its strategic Litigation Department organized the 5<sup>th</sup> Annual National Inter-University Constitutional Law Moot Court Competition at Kampala International University under the theme of the Moot was “*Business, Health and Human Rights.*”

Moots are organized by CEHURD in order to train lawyers in practical areas of litigating health and human rights within Courts of Law, legal writing, and arguing cases in court while maintaining a poise and demeanor that is consistent with Uganda’s legal profession.

The formation of CEHURD was premised on the desire to contribute towards ensuring that laws and policies are used to promote and protect health and human rights of people in Uganda and East Africa at large through research, advocacy, community empowerment and strategic litigation. The moot court Competition is only one of the many ways they have tried to achieve these goals.

This year’s moot sought to address the question of business and human rights, the state’s obligation to protect, respect and supervise private entities that conduct businesses whose impacts affect health and Government’s need to address issues related to sexual and gender based violence within the context of Uganda.

The Moot also sought to test the participants’ knowledge of the law in as far as the right to health and a clean and healthy environment is concerned while taking into consideration the need to carryout business and infrastructural development that respect health and human rights.

The preliminary rounds of this year’s competition started off at 10am and attracted participation from the country’s top Universities namely; ***Cavendish University, Islamic University in Uganda- Kampala Campus, Islamic University in Uganda- Mbale Campus, Uganda Pentecostal University, Bishop Stuart University-Mbarara, Makerere University, Uganda Christian University- Mukono Campus, Uganda Christian University-Kampala Campus, Kampala International University*** in a battle of well researched legal submissions by the participants.

Shortly after the preliminary rounds, ***Makerere University took the lead with 83.57% joined by Uganda Christian University Mukono, 82.57%, Uganda Christian University-Kampala Campus– 77.75% and Islamic University in Uganda-Mbale Campus – 75.5%*** as can be seen below.

The best four teams in the preliminary rounds proceeded to the ***semi-finals*** with Makerere University versing Uganda Christian University-Kampala Campus and Islamic University in Uganda-Mbale Campus versing Uganda Christian University-Mukono Campus with ***Uganda Christian University- Mukono Campus taking the lead with 85.2%, Makerere University with 85.2%*** which qualified for the final round.

The final round of the Moot that was judged by prominent lawyers and distinguished Judges in the field like the **Hon. Mr. Justice Musa Ssekaana- Judge of the High Court, Dr. Zahara Nampewo- the Executive Director of the Human Rights and Centre (HURIPeC), Counsel Mbabazi Nicholas- Partner at Kaggwa and Kaggwa Advocates, Mr. David Kabanda- Programs coordinator – CEHURD and Ms. Primah Kwagala (Programme Manager- Strategic Litigation).**

At the end of the Moot, the Judges computed their results and gave their observations on each of the teams oral presentations and these included;

**Hon. Mr. Justice Musa Ssekaana**, advised law students of this generation to make use of such opportunities, "I've seen many lawyers who cannot even speak even for their clients. The life as a lawyer involves presenting the client's cause at different forums/people. Even for a non-litigating lawyer, mooting skills are essential as they enable one to feel the system by being a participant."

**Mr. David Kabanda (Programs coordinator – CEHURD)** explaining the importance of the moot court competitions, " The main objective of the moot is to train students in practical aspects of litigating health and human rights within Uganda's Courts of Law. The moot specifically aspires to train students in legal writing, arguing cases in court, professional conduct and demeanor while arguing cases and preparation of court pleadings. I believe that whoever has participated in this Moot is a future public interest lawyer".

After the Judges of the Final Panel gave their comments, Justice Musa Ssekaana announced the scores for the final Panel and these were;
